Privacy statement

Data protection statement

Welcome to the Cabinet Dentaire de Satigny website. The following data protection declaration, which applies to the use of our website and the services offered on it, informs you about the collection of personal data during your browsing. By using this website, you consent to the processing of your personal data in accordance with this data protection declaration.

We collect and process your personal data in compliance with the applicable data protection laws and requirements. In all other respects, the dental practice accepts no liability for the use of this website.

In principle, our dental practice offers its services only in Switzerland; it is open to residents of Switzerland and abroad.

Data storage and general information

Each time you visit our website, a series of general data and information are collected and stored in the server log files. The data collected may include (1) the browser types and versions used, (2) the operating system used by the accessing system, (3) the website from which a system accesses our website (called referrer), (4) the sub-sites accessed by a system accessing our website, (5) the date and time of access to the website, (6) an IP (Internet Protocol) address, (7) the Internet service provider of the accessing system and (8) other similar data and information to protect against attacks on our IT infrastructure.

This data and information is necessary to (1) correctly present the content of our website, (2) optimize its content, (3) ensure the long-term operation of our IT infrastructure and the technical aspects of our website, and (4) provide the necessary information to the prosecuting authorities in the event of a cyber attack.

Our dental practice may also analyze this data and information for statistical purposes and to improve the data protection and security of our IT infrastructure. The data and information collected will only be processed for the above-mentioned purposes and will then be deleted.

Links to other websites

This website may contain links to the websites of other providers. Our dental practice has no influence whatsoever on these websites, their content, offers or availability, nor on the data protection declarations and provisions applicable to them, and therefore accepts no liability whatsoever.

Cookies and other services

Our dental practice may use cookies on its website. Cookies contain a unique identifier that associates the website with the user. Cookies contain a unique identifier that associates websites and servers

with a specific web browser. Any web browser can be recognized and identified by this unique identifier.

Such information on the use of this website (including your IP address) may, for example with the use of Google Analytics, be transmitted to servers abroad and stored there. By continuing to use our website, you agree to this transfer of data.

Our dental practice may use other service offerings from third-party providers to integrate their content and services, such as videos or contributions, into our website. For such integration, these third-party providers must be able to collect the IP address and other information of persons visiting this website. By continuing to browse our website, you agree to the above.

Our firm and, where applicable, the company responsible for sending the newsletter, retain personal data for as long as you are subscribed to the newsletter.

Means of communication

Our dental practice's website contains certain information to enable rapid electronic contact and immediate communication, including a general e-mail address. If you contact us via the communication channels offered on our website, your contact details and content will only be used to process and respond to your inquiry.
